Also be aware of plagiarism (https://www.wu.ac.at/en/staff/information-for-teachers/courses-exams-and-theses/theses/plagiarism). The paper you submit should represent a "proper piece of work".
- 5.) Please make sure the file name includes the family names of all group members plus the title of the exercise, e.g.: "Jones Smith Williams _ Differentiated Integration".
